Wagner, P.E., Dallas Water Utilities' Assistant Director of Business Operations, as her replacement. Additional nominations from the planning group and the public will be accepted. RCWPG may take action to fill the position.

John Carman no longer represents the interest he was selected to represent (Municipalities). Per Region C by-laws, a new representative should be elected. The City of Fort Worth has nominated Christopher Harder, P.E.
