RCWPG Minutes from January 6, 2025

MINUTES OF AN OPEN PUBLIC MEETING January 6, 2025

The Region C Water Planning Group (RCWPG) met in an open public meeting on Monday, January 6, 2025, at 1:00 P.M. The meeting was held at the North Central Texas Council of Governments located at 616 Six Flags Drive, Centerpoint Two Building, First Floor Transportation Council Room, Arlington, Texas. Notice of the meeting was legally posted.

Chairman Kevin Ward called the Region C Regional Water Planning Group meeting to order at approximately 1:05 P.M. and welcomed guests.

I. ROLL CALL

Kevin Smith, TWDB, Kathy Jones, Region G, and Ronna Hart, Region D, were present. The registration lists signed by guests in attendance are attached.

II. APPROVAL OF MINUTES - September 30, 2024

The minutes of the September 30, 2024, RCWPG meeting were approved by unanimous consensus by the RCWPG.

III. PUBLIC COMMENTS (Limited to 3 minutes per speaker)

One speaker made public comments but asked to delay comments until after the last item.

IV. PRIMARY ACTION ITEMS FOR CONSIDERATION

A. Amend the Region C Bylaws Article IV.1 (Officers) to remove the requirement that two voting members representing the same interest group cannot serve as officers at the same time. Amended the Region C Bylaws Article VII.2 (Voting Membership) to allow a person retired from a represented interest to serve as a voting member for said interest.

Chairman Ward presented this item to consider recommendations to amend the Bylaws as mentioned above.

There were no public comments on this action item.

Upon a motion by Steve Mundt, and a second by Denis Qualls, the Region C WPG voted unanimously to amend the Region C Bylaws Article IV.1 (Officers) to remove the requirement that two voting members representing the same interest group cannot serve as officers at the same time; and amended the Region C Bylaws Article VII.2 (Voting Membership) to allow a person retired from a represented interest to serve as a voting membership for said interest.

B. Announcement of Region C RWPG voting member vacancies: Kevin Ward representing River Authorities; Call for nominations to fill vacancy and vote to fill vacancy.

Chairman Ward expressed his appreciation for time served on the Region C WPG board. Chairman Ward also recommended Glenn C. Clingenpeel as his replacement. Chairman Ward call for nominations from the floor but heard none.

There were no public comments on this action item.

Upon a motion by Dan Buhman, and a second by Doug Shaw, the Region C WPG voted unanimously to approve Glenn C. Clingenpeel to fill the River Authorities vacancy left by the resignation of Kevin Ward.

C. Announcement of Region C RWPG Chair vacancy; Call for nominations for a nominating committee to fill vacancy and vote to appoint a nominating committee.

Chairman Ward reiterated his appreciation for the opportunity to serve as the Region C WPG chairman for the past five years. Steve Mundt and Jenna Covington expressed their gratitude for Chairman Ward's service. Chairman Ward asked the planning group for volunteers to form a Nominating Committee to give their recommendation for his replacement as Chairman at the next scheduled Region C WPG meeting.

There were no public comments on this action item.

Upon a motion by Grace Darling, and a second by Jenna Covington, the Region C WPG voted unanimously to appoint Jay Barksdale, Chris Harder, Steve Mundt, and Denis Qualls as members of a Nominating Committee to make a recommendation at the next scheduled Region C WPG meeting to fill the Chair vacancy left by resignation of Kevin Ward.

A. Draft Chapter 4 Overview (Identification of Water Needed)

Christina Gildea, FNI, gave this presentation on Chapter 4 which gives an identification of water needed. Ms. Gildea highlighted the following contents:

- Regional Comparison of Supply and Demand
- Comparison of Connected Supply and Projected Demand by MWP

- Comparison of Connected Supply and Projected Demand by Other Water Providers
- Summary of Projected Water Shortages
- Second-Tier Needs Analysis

Projected Needs

- Regional needs:
 - 221,000 AF/Y in 2030
 - 1.33 million AF/Y in 2080
- WUGs with needs:
 - 224 in 2030
 - 272 in 2080
- All Region C counties show a need by 2040
- Largest water needs are in Collin, Dallas, Denton, and Tarrant Counties
- B. Draft Chapter 5A Overview (Methodology for Evaluation and Selection of WMS)

Christina Gildea, FNI, gave this presentation on Chapter 5A which covers types of Water Management Strategies and methodology for Evaluating Water Management Strategies.

Types of Water Management Strategies

Below are Water Management Strategies considered for Region C:

- Water conservation
- Water reuse
- Management of existing water supplies
- New Supply Development
 - New surface water
 - New groundwater
- Desalination
- Aquifer storage and recovery
- Interbasin transfers
- Emergency transfer of water

Below are Water Management Strategies not considered for Region C:

- May be Considered, if Requested by WUG
 - Drought management
 - o Brush control
 - Rainwater harvesting
 - Precipitation enhancement
- Not Recommended for Region C
 - Cancellation of Water Rights

Water Management Strategy Evaluation Factors

- Recommended Strategies are based on the ability to supply the quantity of water needed at a reasonable cost while providing long-term protection of the state's resources
- TWDB required strategy evaluation factors
- Consistency with on-going water development plans for water providers is an important factor

Strategy Evaluation Factors

- Quantity of water made available
- Reliability of supply
- Unit cost of delivered and treated water
- Environmental factors
- Impacts on agricultural and rural areas
- Impacts on other water management strategies and possible third-party impacts
- Impacts to key water quality parameters
- Consistency with plans of Region C water suppliers
- Consistency with other regions
- C. Update on Recommended WMS for Major Water Providers.

Simone Kiel, FNI, gave an update on recommended Water Management Strategies (WMS) for Major Water Providers (MWP). MWPs are entities of "particular significance" to the region's water supply. The six MWPs in Region C are:

- Tarrant Regional Water District (TRWD)\
- Dallas Water Utilities (DWU)
- North Texas Municipal Water District (NTMWD)
- Trinity River Authority (TRA)
- Upper Trinity Regional Water District (UTRWD)
- Fort Worth

Major Water Providers Overview

- Needs before strategies
- Draft recommended and alternative strategies
- Draft strategy unit costs
 - TWDB Unified Costing Model
 - September 2023 Dollars

Ms. Kiel commented that the Region C MWPs provide 90% of water to the region.

D. Update on Conservation – Recommendations for Region C

Ellen McDonald and Qiwen Zhang, Plummer, gave this update from the Region C Conservation Subcommittee which met on October 16 and 28, 2024. The subcommittee identified two guiding principles of the water conservation recommendations in the Region C Plan:

- Continued improvement in conservation that demonstrates the Region's commitment to using existing sources efficiently
- Reasonable, practical recommendations that do not put an undue financial burden on WUGs

Listed below are the Best Management Practices and Applicable WUGs:

•	Public and school education	All Municipal WUGs
•	Price elasticity/rate structure impacts	All Municipal WUGs
•	Water waste ordinance	All Municipal WUGs
•	Time-of-day irrigation restriction	All Municipal WUGs
•	Water conservation coordinator	WUGs w/population> 10,000
•	Twice weekly irrigation restriction	WUGs w/population> 20,000
•	Landscape ordinance for new development	WUGs w/population> 20,000
•	Water Loss Mitigation Strategy	All Municipal WUGs

Water Loss Mitigation Strategy

- SWIFT Funding Eligibility
 - Water Loss Mitigation WMSs expected to quality
- Recommendation
 - Recommend Water Loss Mitigation WMSs to all municipal WUGs
 - Savings tied to existing water loss and TWDB water loss thresholds
 - For WUGs without audit data or compliant with thresholds, assume minimal savings (0.5% of demand) for main replacement funding applications

Landscape Ordinance for New Development

- New strategy this cycle
- Target outdoor water use in areas with growth
- A general strategy that enables WUGs to design ordinances tailored to their specific conditions

E. Draft Chapter 7 Overview (Drought Response)

Qiwen Zhang and Brigit Buff, Plummer, gave this update on the changes in the Scope of Work for Chapter 7 – Drought Response. Following are the changes to Chapter 7 from the previous cycle:

- Section 7.2 Uncertainty and Drought(s) Worse than the Drought of Record
 - Safe yield analysis
 - Plan for greater supply
 - o Dry-year baseline
 - Conservation Progress

Changes from Previous Cycle

- Updated analyses with new data on the following items:
 - Drought Contingency Plans, drought triggers, goals, and response measures
 - Emergency interconnects, and
 - Emergency responses to local drought conditions or loss of municipal supply
 - Recommendations from the Drought Preparedness Council
- F. Draft Chapter 8 Overview (Unique Stream Segments, Unique Reservoir Sites, and Legislative Recommendations).

Brigit Buff and Ellen McDonald, Plummer, gave this presentation on Chapter 8. Ms. Buff advised that surveys were sent out on September 9, 2024, to gather input from the Regional Water Planning Group. There were responses from three entities, and those were incorporated.

- No changes from Previous Cycle
- 10 total TPWD recommendations (2002)
- Previous RWPG recommendation:

- Continue and expand funding of Groundwater Conservation Districts
- Funding for NRCS structures as a form of watershed protection

 - Support research to advance reuse and desalination
